What are some of your objectives for the year ahead?



Jon Dorenbos Former NFL Pro Bowler and Professional Magician






Life Service Award: **Bruce Leetz**

A Living Legacy of Passion and Vision

A man of faith, family and deep respect for all people, Bruce Leetz showed that competition can go hand-in-hand with consideration during his 40 years leading Indana Beverage.

Bruce got his start in the beer industry as the fifth employee of then-Valpo Beverage, spending his first six years in the industry delivering beer in a red pick-up truck. After taking over the presidency in 1969, Bruce's steady hand at the wheel and passion for excellence helped Indiana Beverage emerge as one of the country's leading beer distributors, acquiring new brands and winning countless honors. Bruce himself was twice awarded Indiana's highest civilian honor, the Sagamore of the Wabash.





Hero Driver Answers the Call

It began as a morning like any other at Petitpren Inc. in Michigan. Justen Bechamp was hard at work delivering beer to the retailers throughout Metro Detroit when he was alerted about a violent crime in process.
